#### **Concerning Public Education in Ohio:**

Ohio legislation has been pushing a voucher system called Ed Choice Scholarship. Voucher expansions have unleashed a flood of additional \$439 million dollars this year of taxpayer dollars to the benefit of families already enrolled in private schools. The demand for the expanded voucher programs are coming from white families, quite affluent, rather than students in lower income and non-white families to have access to a private school.

• The private schools are exempt from following an accepted curriculum and can be religious or non-sectarian and do not have the accountability of public schools. While public schools have the responsibility and the duty to serve all students, regardless of their race, their gender, their family income, regardless of who they are or their abilities, private schools can choose who will attend their schools.

- Disabled students will not get the help that they need if they are in a private School.
- They do not have to administer the same state tests as public schools.
- Ed Choice schools do not require background checks for teachers nor do the teachers need to be certified and licensed.
- For profit management teams can manage non-profit schools so taxpayer dollars can be funneled into the for-profit activities, which is against the constitution in Ohio.

If we want to preserve our public school system, we need to monitor this system closely and object to funds being taken from the majority of students in public schools.
