From National:

For decades, women have been breaking into science, technology, engineering, and math but persistent barriers continue to block the path to equity.

- AAUW branches support STEM by organizing hands-on programs, funding scholarships, and advocating for equity in STEM education, innovation, and careers.

Update on funding for vouchers in Ohio:

Mr. Curtin, a former editor and associate publisher for the Columbus Dispatch, a two-term state lawmaker who served on the Ohio Constitutional Modernization Commission, recently wrote an article looking at the history of funding public schools with taxpayers in Ohio and the decision by voters 175 years ago to stop tax dollars from going to private, religious

schools. Franklin County Judge Jaiza Page, who ruled in June that the EdChoice private school voucher program is unconstitutional on three counts, quoted "the plain words of delegates to Ohio's Constitutional Convention of 1850-51, who adopted language to ensure school funds of the state would be used solely to support common (public) schools." Ohio Supreme Court Chief Justice Sharon L. Kennedy vows: "As justices, we are required to faithfully, fairly, and impartially uphold the law as written. We do not rewrite it or legislate from the bench." Curtin quotes Justice R. Patrick DeWine (he's Gov. Mike DeWine's son) from a December article for the Ohio State Law Journal pledging adherence to "an original public meaning approach to the Ohio Constitution." So why are we still funding vouchers?



Update on current requirements from U.S. Department of Education:

The expansive 10-point memo, dubbed the "Compact for Academic Excellence in Higher Education," puts forth a wide-ranging set of terms the administration says are intended to elevate university standards and performance. Universities that sign on will get "multiple positive benefits," including "substantial and meaningful federal grants," according to a letter addressed to university leaders. The compact asks universities to ensure a "vibrant marketplace of ideas on campus" and to bar employees from expressing political views on behalf of their employer unless the matter affects the school. It seeks to create a more-welcoming environment for conservatives, asking colleges to make governance changes and abolish departments that "purposefully punish, belittle, and even spark violence against conservative ideas." he memo demands that schools ban the use of race or sex in hiring and admissions; freeze tuition for five years; cap international undergrad enrollment at 15%; require that applicants take the SAT or a similar test; and quell grade inflation. The document focuses on the campus political climate.



Observation by Jorine Stone in Portland, OR

"The activities and speeches of government representatives continues and not much of it includes support of AAUW's goals or mission. Please remember that we need to continue to voice our opinion and contact our state and national Senators and Representatives. When I

was in Portland, Oregon recently, I participated in two protests, one in support of green energy to help our planet, another against the use of the military against the citizens of this country. It was all very peaceful. I saw no evidence of any violence. It is discouraging to think that our voice is not being heard at all." Jorine Stone stated.
